INTRODUCTION

- 1. The Indian Coast Guard (ICG) was established on 01 Feb 1977, as an armed force of the Union, with the mandate of ensuring the safety, security and stewardship of India's vast maritime interests. Operating under the Ministry of Defence, the ICG has grown into a formidable force dedicated to the mission of "protecting India's maritime interests and enforcing maritime law over the vast Maritime Zones of India."
- 2. In Oct 25, Indian Coast Guard conducted multilateral events, 10th National Pollution Response Exercise (NATPOLREX-X) and 27th NOSDCP Meeting from 05 to 06 Oct 25 at Chennai. Director General Paramesh Sivamani, AVSM, PTM, TM, DGICG & Chairperson, NOSDCP inaugurated the exercise and meeting. 39 foreign observers from 32 countries and more than 100 national delegates participated in the event, which marked a major step towards global collaboration. The event was focused on strengthening oil spill response readiness through enhanced cooperation and adoption of global best practices.
- 3. Further, in Oct 25, ICG maintained a robust operational tempo, remaining alert and responsive while executing critical missions such as Search and Rescue (SAR) operations, Medical Evacuations (MEDEVAC), anti-smuggling drives, marine pollution control and MZI patrols. These activities underscore the ICG's unwavering commitment to mission of ensuring maritime safety and national security.

MAJOR OPERATIONS

A. Anti-Smuggling Operation.

On 02 Oct 25, based on an input, ICG Station Mandapam and Customs seized 800 Kg Sea Cucumber worth ₹3.6 crore from an IFB alongwith 01 poacher off Pamban, Tamil Nadu. The IFB alongwith crew and contraband were handed over to Customs Department, Mandapam.

MAJOR OPERATIONS

On 11-12 Oct 25, ICG conducted joint operation with Coastal Security Group (CSG) and Customs off Morepannai, Thirupalaikudi and Mullimunai (TN). A total of 55 Kg (ICG 20 Kg and CSG 35 Kg) of Ganja was seized during operation. The seized contraband was handed over to CSG Thondi.

SEARCH & RESCUE

A. SAR Efforts for Man Overboard from Indian Fishing Boat Manik Prasad (Regd. No. IND-GJ-14-MM-172).

On 03 Oct 25, ICG received an information from VTS Khambhat Hazira, Gujarat regarding man overboard from IFB Manik Prasad in position 06 N miles South of Jafrabad, Gujarat. On receipt of information, ICG Ship C-419 was deployed to augment SAR efforts and recovered the survivor from rescue boat of MV Al Hadbaa. Thereafter, the ICG Ship handed over the survivor to Fisheries Department, Jafrabad.

B. SAR efforts for Man Overboard from Unregistered Motorised Fishing Boat.

On 08 Oct 25, ICG received an information from AD Fisheries, Cuddalore, Tamil Nadu regarding man over board from unregistered motorised fishing boat in position 4.5 N miles South-West of Cuddalore, Tamil Nadu. On receipt of information, extensive search was carried out by 04 ICG surface assets. On 10 Oct 25, AD Fisheries, Cuddalore intimated that the body of missing fisherman was recovered between Chitrapettai and Rasapettai, Cuddalore Tamil Nadu.

C. SAR Efforts for Man Overboard from Unregistered Fishing Boat Nithin.

On 23 Oct 25, ICG received an information from AD Fisheries Nagercoil, Colachel, Tamil Nadu regarding man overboard from unregistered fishing boat in position 7.5 N miles South-West of Cape Comorin, Tamil Nadu. On receipt of information, extensive search in coordination with Coastal Security Group (CSG), Kanyakumari was carried out by 03 ICG assets. However, nil survivor/body was sighted.



A. Conduct of 10th National Level Pollution Response Exercise (NATPOLREX-X) and 27th National Oil Spill Disaster Contingency Plan (NOSDCP) Meeting off Chennai

Indian Coast Guard conducted National Level Pollution Response Exercise (NATPOLREX-X) and 27th NOSDCP Meeting from 05 to 06 Oct 25 off Chennai. Director General Paramesh Sivamani, AVSM, PTM, TM, DGICG & Chairperson, NOSDCP inaugurated the exercise and meeting. The exercise witnessed remarkable international participation, reaffirming India's leadership in regional maritime cooperation. 39 foreign observers from 32 countries and more than 100 national delegates participated in the event. Their participation underscored growing global confidence in India's pollution response capability and its commitment to collective marine environmental protection. Through joint deliberations and live demonstrations, NATPOLREX-25 strengthened the spirit of partnership and interoperability among maritime stakeholders in the Indian Ocean Region, contributing to a cleaner, safer, and more secure marine environment.

B. ICG participation in 6th Defence Cooperation Dialogue Meeting at Maldives.

To further bolster the long-standing defence partnership between India and the Maldives and advance the shared interests of both nations in maintaining stability and prosperity in the Indian Ocean Region, the Additional Director General, Indian Coast Guard, participated in the 6th India–Maldives Defence Cooperation Dialogue, held from 05 to 07 Oct 25 in the Maldives, as part of the Defence Secretary-led Indian delegation. The discussions centered on capacity building, training programmes, joint military exercises, and the continued strengthening of bilateral defence cooperation.

C. Conduct of Maritime Law and Operations Course at CGTC, Kochi.

Indian Coast Guard under the aegis of ITEC programme by MEA, conducted a Maritime Law & Operations Course from 06 to 31 Oct 25 at Coast Guard Training Centre, Kochi. 19 officers from Friendly Foreign Countries participated in the training. This programme, conducted by the ICG combined classroom studies and hands-on training on international maritime law, search and rescue, marine pollution response, and boarding operations. By fostering collaboration and knowledge exchange among international participants, the training reinforced India's commitment to regional maritime security and professional excellence in the coastal domain.

D. ICG Participation in Lifeguard Basic Level, First Air and CPR Course at Sri Lanka.

03 ICG personnel visited Sri Lanka to participate in Lifeguard Basic Level Course with Sri Lanka Coast Guard at Balapitiya, Sri Lanka from 06 to 17 Oct 25 to enhance their lifesaving skills. This collaborative training, conducted by certified instructors, provided a blend of theoretical and practical



sessions covering marine rescue, emergency medical care, and CPR, empowering the sailors to respond effectively to emergencies in diverse maritime environments. Their involvement reflects the strong regional partnership in maritime safety and the commitment of both nations to fostering excellence in lifesaving operations.

E. Conduct of 3rd Marine Pollution Response Workshop at Chennai.

Participants from Sri Lanka, Maldives, Mauritius, Bangladesh and observer nation Seychelles participated in the workshop. The workshop was aimed to enhance regional coordination, interoperability & capacity building for effective marine pollution response, reinforcing collective preparedness and environmental resilience in the Indian Ocean Region under India's 'Neighbourhood First' policy.




C. Coastal Maritime Traffic.


Indian Coast Guard monitored 8,470 distinct AIS transmission on CSN network along Indian coast in the month of Oct 25. Traffic share of India, Panama, Liberia, Marshall Island, China & Hong Kong and Singapore stood at 42%, 10%, 08%, 06%, 04% and 04% respectively. The larger share of India flagged traffic is attributed to coastal traffic. Traffic share of Cargo and Tanker vessels is 29% and 21% respectively. A total of 2,965 vessels were investigated by ICG ROS. The state-wise, flag-wise and type-wise traffic pattern is depicted below:-






D. Fishing Activities in North Indian Ocean.

A total of 2084 Fishing Vessels (FV) were observed transmitting on AIS in Northern Indian Ocean in the month of Oct 25. The analysis of fishing activities is based upon kinematics such as low speed. The data towards numbers of FV have been garnered from AIS transmission. However, the actual numbers of FV may be higher than the reported data as many FV may not be transmitting on AIS. The area wise analysis of FV operating in Indian EEZ, High Seas in Bay of Bengal and Arabian sea for the month of Oct 25 is as follows:-

- (i) Arabian Sea (Beyond EEZ). A total of 729 FV were observed transmitting on AIS and appreciated to be engaged in fishing. Out of these, numbers of Iranian, Chinese, Sri Lankan, Indian and Pakistani FV were 37%, 30%, 18%, 09% and 02% respectively. Chinese FV were observed arriving in Arabian Sea in end Oct 25 post monsoon period.
- (ii) Indian EEZ. A total of 1246 Indian flagged FV were observed transmitting on AIS. Additionally, AIS transmissions of 1332 fishing net/ buoys were also observed. Majority of FV




were observed operating on west coast of India. No foreign FV were observed engaged in fishing in Indian waters.

(iii) **Bay of Bengal (Beyond EEZ)**. A total of 109 Sri Lankan and 01 Indian FV were observed transmitting on AIS and appreciated to be engaged in fishing. No other flagged FV observed transmitting on AIS in high seas Bay of Bengal.

E. Maritime Incidents & SAR Cases in Maritime Zones of India (MZI) and Indian Search & Rescue Region (ISRR).

- (i) **Maritime Incidents**. A total of 10 incidents were reported in Maritime Zones/Search and Rescue Region of India in Oct 25.
 - (aa) **Distress**. One distress incident was reported onboard Indian Fishing Boat due to capsizing in Oct 25. Of the 18 fishermen onboard IFB, 16 were rescued, one body recovered and one survivor/body remained missing.
 - (ab) **Man Over Board**. Five cases of Man Overboard (MOB) onboard IFBs were reported in Oct 25. 01 survivor rescued by MV, two bodies were recovered by local fishermen and two survivors/bodies were missing.
 - (ac) **Drowning**. Two cases of beach drowning, one each at Tamil Nadu and Andhra Pradesh coast were reported in Oct 25.
 - (ad) **Medical Emergency**. One case of Medial Emergency was reported onboard MT Feather. Patient was evacuated by Tug arranged by local agent & shifted to hospital.
 - (ae) **Stranded**. One incident of stranding of IFB due to engine failure was reported in Oct 25. The IFB reached Honnavar fishing harbour, Karnataka safely with assistance of another fishing boat.
- (ii) **Contraband**. Two incidents of contraband were reported in the month of Oct 25. ICG seized 800 kg of Sea Cucumber worth ₹ 3.6 crore and 1200 Kg of Tendu Leaves worth ₹ 5.5 Lakhs respectively.



Coast Guard to hold oil spill drill off TN coast

Chennai: The Indian Coast Guard will hold a two-day national oil spill response exercise off the Tamil Nadu coast from Sunday, bringing together domestic agencies and international observers. The 10th National Level Pollution Response Exercise (NATPOLREX-X), alongside the 27th National Oil Spill Disaster Contingency Plan meeting, will test India's preparedness for marine oil spills and inter-agency coordination. More than 100 national delegates and 40 observers from 32 countries are expected to participate. The Coast Guard will deploy ships and aircraft equipped for pollution control to demonstrate operational readiness and international cooperation.

Indian Coast Guard Conducts Xth NATPOLREX-X And 27th NOSDCP Meeting At Chennai



The Indian Coast Guard (ICG) conducted the 10th edition of the National Level Pollution Response Exercise (NATPOLREX-X) along with the 27th National Oil Spill Disaster Contingency Plan (NOSDCP) & Preparedness Meeting on 05–06 Oct 2025, off the coast of Chennai, Tamil Nadu. This biennial flagship exercise is a cornerstone in strengthening India's preparedness to combat marine oil spills in accordance with the National Oil Spill Disaster Contingency Plan (NOSDCP).

The event was overseen by Director General Paramesh Sivamani, AVSM, PTM, TM, Director General, Indian Coast Guard, and Chair-person, NOSDOP, who reviewed the exercise and assessed the operational readiness, response coordination, and inter-agency synergy

ational readiness, response coordination, and inter-agency synergy among participating stakeholders. The large scale exercise witnessed enthusiastic participation from a wide spectrum of stakeholders, including representatives from central ministries, coastal state governments, major ports, oil handling agencies, and maritime organizations. Notably, 40 foreign observers from 32 countries and over 105 national delegates attended the exercise and actively contributed to discussions in the 27th NOSDCP meeting, held concurrently. The technical sessions of NATPOLREX-X featured insightful presentations on topics of current relevance, including Nurdle Spills and their Environmental Impact, Case Studies on Hazardous and Noxious Substances (HNS), Post-Spill Monitoring & Environmental Impact Assessments, Shoreline Cleanup following MV MSC ELSA 3 incident, ICG Coordination and Response during MV MSC ELSA 3 MV Wan Mai 503 Incidents, These sessions provided a knowledge-sharing platform for environmental scientists, policy makers, and operational experts to collaboratively discuss strategies for effective spill response and post-incident recovery. The ICG deployed a full spectrum of assets to demonstrate its oil spill response capabilities, including Pollution Control Vessels (PCVs), Offshore Patrol Vessels (OPVs), Fast Patrol Vessels (FPVs), Chetak and Dornier Aircraft configured for aerial surveillance and pollution response. The current exercise is unique in the fact that it incorporates the first-ever shoreline clean up drill, at Marina Beach, by the Greater Chennal Cooperation, State Pollution Control Board, SDMA, Police and other agencies of Tamil Nadu administration as part of the simulated incident. These demonstrations validated the efficiency and readiness of the ICG's multi-layered pollution response mechanism, while also emphasizing the importance of joint operations with ports and coastal authorities. अरब सागर में '<mark>अजित</mark>' और 'अपराजित' का जलावतरण

नई दिल्ली, 24 अक्तूबर (नवोदय टाइम्स): भारतीय तटरक्षक बल ने मेसर्स गोवा शिपयार्ड लिमिटेड में दो उन्नत तीव्र गति वाले गश्ती पोतों 'अजित'और 'अपराजित'का जलावतरण शुक्रवार को अथर्ववेद के मंत्रोच्चार के साथ अरब सागर में किया। ये पोत जीएसएल द्वारा तटरक्षक बल के लिए निर्मित आठ पोतों की श्रंखला में 7वें और 8वें पोत हैं।

इस अवसर पर रक्षा मंत्रालय के वित्तीय सलाहकार (रक्षा सेवाएं) डॉ. मयंक शर्मा और मंजू शर्मा के साथ आईजी भीष्म शर्मा और आईसीजी व जीएसएल के अन्य वरिष्ठ अधिकारी मौजूद रहे।शर्मा ने कहा, आत्मनिर्भर भारत के दृष्टिकोण के अनुरूप, यह परियोजना स्वदेशी नवाचार की शक्ति को प्रदर्शित करती है और स्थानीय उद्योग, रोजगार सृजन और एमएसएमई पारिस्थितिकी तंत्र में महत्वपूर्ण योगदान देती है। ये जहाज 52 मीटर लंबाई



और 320 टन विस्थापन के साथ भारत में इस श्रेणी के लिए अपनी तरह के पहले, कंट्रोलेबल पिच प्रोपेलर (सीपीपी) से सुसज्जित हैं। इन फुर्तीले प्लेटफार्मों को मत्स्य संरक्षण, तटीय निगरानी, तस्करी-रोधी, समुद्री डकैती-रोधी और खोज एवं बचाव कार्यों, विशेष रूप से भारत के द्वीपीय क्षेत्रों और विशेष आर्थिक क्षेत्र के आसपास, के लिए तैनात किया जाएगा।

ICG evacuates critically injured fisherman

Kochi: Indian Coast Guard (ICG) successfully conducted a long-range medical evacuation of a critically injured Iranian fisherman following an explosion during fuel transfer to the generator on the fishing dhow Al-Owais.

The five-crew vessel with engine failure was located in the middle of Arabian Sea, approximately 1,500km west of Kochi. The fisherman had injuries to both eyes and deep lacerations on the right ear, said a PIB statement. It added that the Maritime Rescue Coordination Centre (MRCC), Mumbai, received information from MRCC Chabahar, Iran, regarding the medical emergency.

ICG ship Sachet on return passage from an overseas deployment to East African countries and MT STI Grace which is a Marshall Islands-flagged tanker en route from Kuwait to Moroni, were directed to render immediate assistance. The crew of the tanker administered tele-medical first aid and stabilisation under guidance from ICG personnel. Further, MT STI Grace met with ICG ship Sachet for patient transfer and further medical management. The fisherman is currently receiving treatment onboard ICG ship Sachet, which is proceeding towards Goa for further procedures. TNN
