INTRODUCTION

1. The Indian Coast Guard (ICG) was established on 01 Feb 1977, as an armed force of the Union, with the mandate of ensuring the safety, security and stewardship of India's vast maritime interests. Operating under the Ministry of Defence, the ICG has grown into a formidable force dedicated to the mission of "protecting India's maritime interests and enforcing maritime law over the vast Maritime Zones of India."
2. In Sep 25, the 42nd Indian Coast Guard Commanders' Conference was held at Coast Guard Headquarters, New Delhi from 28 to 30 Sep 25. The Conference was graced by Hon'ble Raksha Mantri Shri Rajnath Singh. Hon'ble RM commended ICG's steadfast professionalism, dedication and operational excellence in safeguarding India's maritime frontiers. The conference underscored ICG's pivotal role in ensuring maritime safety, security, environmental protection and aligns with the national vision of a secure, stable and resilient maritime domain.
3. Under the "Swachhta Hi Seva Campaign-2025", Indian Coast Guard units organised a massive coastal cleanup drive across Indian coastal regions. The initiative aimed to raise public awareness about the importance of preserving and protecting beaches, marine ecosystems and the maritime environment.
4. Further, in Sep 25, the ICG maintained a robust operational tempo, remaining alert and responsive while executing critical missions such Search and Rescue (SAR) operations, Medical Evacuations (MEDEVAC), anti-smuggling drives, marine pollution control and MZI patrols. These activities underscore the ICG's unwavering commitment to its duties and mission of ensuring maritime safety and national security.

MAJOR OPERATIONS

A. Anti-Smuggling Operation.

On 11 Sep 25, based on an input, ICG carried out a swift anti-narcotics operation and seized 96 Kg Tendu Leaves and 118 Kg Dry Ginger from 3rd Island, Dhanushkodi. The seized consignment was handed over to Customs Department, Rameshwaram for further legal action.

B. Anti-Poaching Operation.

On 09 Sep 25, based on int input, ICGS Aruna Asaf Ali in a sea-air coordinated operation intercepted a Myanmar boat near East Island and apprehended 03 Myanmar poachers at 2145 hrs. 06 other poachers of the group were apprehended by A&N Police from the East Island on 11 Sep 25.

MAJOR OPERATIONS

On 17 Sep 25, ICG ship on IMBL patrol apprehended 01 Bangladesh Fishing Boat (BFB) 'Mayer Doya' alongwith 13 crew in position 115 Sagar Lt 66.5 n miles for carrying out illegal fishing in Indian waters. The BFB alongwith 13 crew was brought to Frazerganj and handed over to Marine Police for further action.

On 11 Sep 25, ICG received information from Assistant Director of Fisheries, Androth regarding missing IFB Najiya alongwith 04 crew onboard since 08 Sep 25 in position approx. 30 n miles North-East of Androth, Lakshadweep. On receipt of information, ICG Ships and aircrafts were tasked for SAR operation and aerial search respectively. On 15 Sep 25, IFB Najiya alongwith 02 fishermen were located by another IFB and brought under tow to Tanur fishing harbour, Kerala

B. Medical Evacuation from MV Haje Nafela (IMO- 9186479).

On 15 Sep 25, ICG received information from the master of Belize flagged vessel MV Haje Nafela regarding medical emergency of a crew (Syrian national) onboard in position 202 n miles South-East of Chennai. The patient had sustained a head injury and merited urgent medical evacuation. On receipt of information, ICG ship C-440 was tasked for evacuating the patient. On 16 Sep 25, ICGS C-440 evacuated and shifted the patient to Isabel Hospital, Chennai for further medical management.

C. Sinking of MV MSC ELSA 3 (IMO – 9123221).

MV MSC ELSA 3 sank approx. 42 n miles south of Kochi on 25 May 25. At present, 68 Containers of the vessel had been washed ashore and shifted to safe locations. In addition, Diving Support Vessel (DSV) MV Southern Nova is engaged in saturation diving alongwith Offshore Supply Vessel (OSV) Monarch (Functioning as Oil Storage Facility) and tug Canera Megh (Guard Vessel). Approx. 198 tons of fuel has been extracted by end Sep 25. Extraction is still in progress.



COOPERATION WITH FOREIGN MARITIME AGENCIES

A. Visit of ICG Delegation to Rome, Italy led by DGICG for 4th CGGS.

A multilateral event, the 4th Coast Guard Global Summit (CGGS) was held at Rome, Italy from 11 to 12 Sep 25. A two member ICG delegation led by Director General Paramesh Sivamani, AVSM, PTM, TM, DGICG participated in the summit. The meeting focused on maritime safety, marine environmental protection and combating transnational maritime crimes. Dignitaries from 115 countries participated in the event. The Prime Minister of Italy, H.E. Giorgia Meloni attended in person, while the Prime Minister of Japan, H.E. Shigeru Ishiba joined virtually. Both leaders emphasized the importance of international cooperation in Marine Pollution Response, Maritime Search and Rescue and Maritime Law Enforcement. ICG also delivered a keynote presentation titled “Guardians against the Blaze” showcasing the organization’s tactical expertise in fire emergency response.

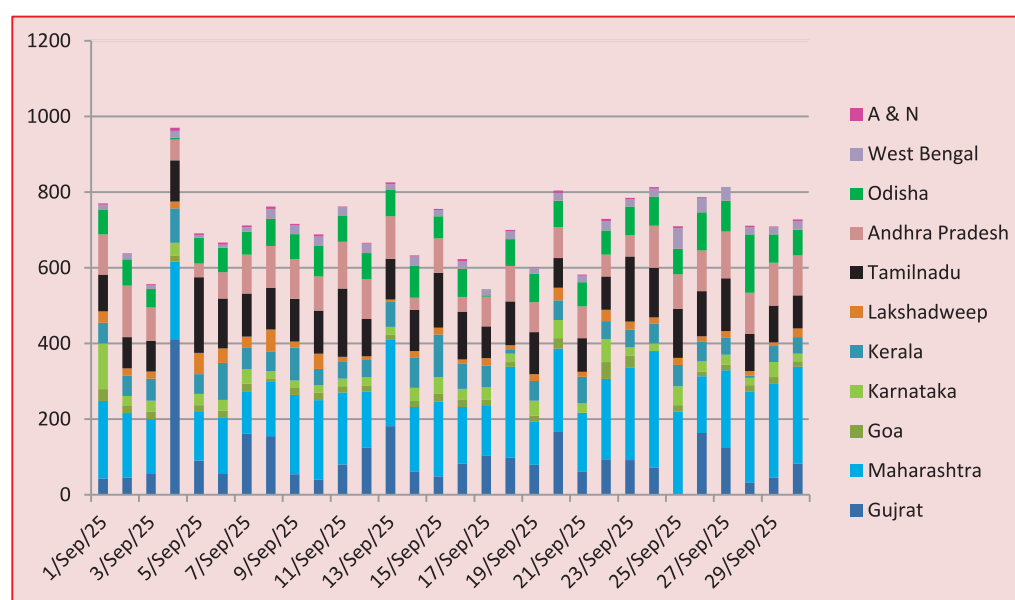

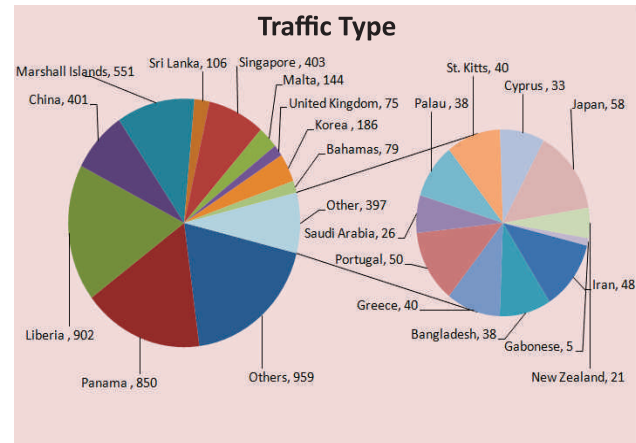
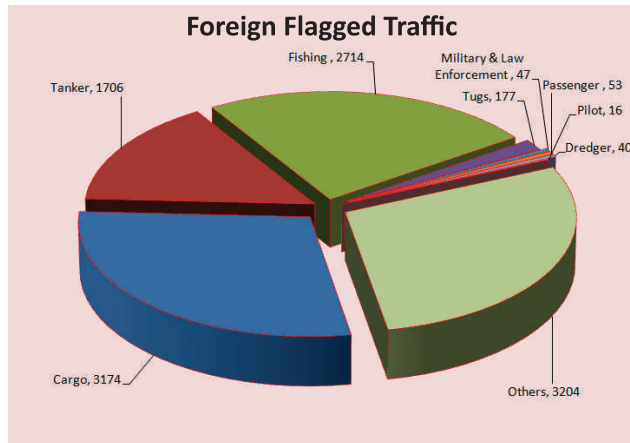
C. Coastal Maritime Traffic.

Indian Coast Guard monitored 11,131 distinct AIS transmissions on CSN network along Indian coast in the month of Sep 25. Traffic share of India, Panama, Liberia, Marshall Islands, China & Hong Kong and

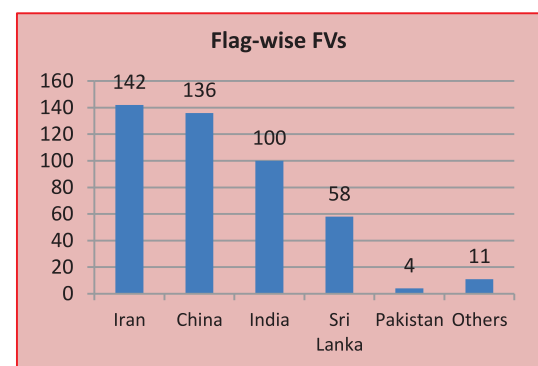
Singapore stood at 55%, 08%, 08%, 05%, 04% and 04% respectively. The larger share of Indian flagged traffic is attributed to coastal traffic. Traffic share of Cargo and Tanker vessels are 29% and 15% respectively. A total of 3,084 vessels were investigated by ICG ROSs. The state-wise, flag-wise and type-wise traffic pattern is depicted :-



D. Fishing Activity in North Indian Ocean.

A total of 3246 Fishing Vessels (FVs) were observed transmitting on AIS in Northern Indian Ocean in the month of Sep 25. The analysis of fishing activities is based upon kinematics such as low speed. The data towards numbers of FVs have been garnered from AIS transmission. However, the actual numbers of FVs may be higher than the reported data as many FVs may not be transmitting on AIS. The area wise analysis of FVs operating in Indian EEZ, High Seas in Bay of Bengal & Arabian sea (beyond EEZ) for the month of Sep 25 is as follows:-

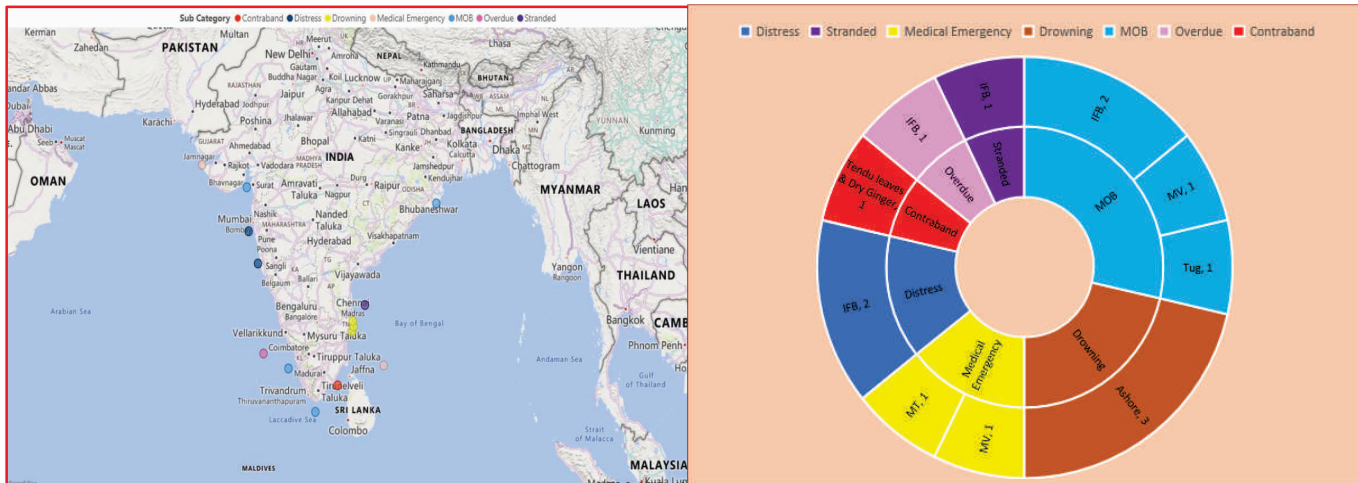
(i) **Arabian Sea (Beyond EEZ).** A total of 451 FVs were observed transmitting on AIS and appreciated to be engaged in fishing. Out of these, numbers of Iranian, Chinese, Indian, Sri Lankan and Pakistani FVs are 31%, 30%, 22%, 13% and 1% respectively. Chinese FVs were observed arriving in Arabian Sea in end Sep 25 post Monsoon period.



(ii) **Indian EEZ.** A total of 2714 Indian flagged FVs were observed transmitting on AIS. Majority of FVs were observed operating on west coast of India. No foreign FVs were observed engaged in fishing in Indian waters.

(iii) **Bay of Bengal (Beyond EEZ).** A total of 77 Sri Lankan, 03 Chinese and 01 Indian FV were observed transmitting on AIS and appreciated to be engaged in fishing. No other flagged FVs were observed transmitting on AIS in high seas Bay of Bengal.

E. Maritime Incidents & SAR Cases in Maritime Zones of India (MZI) and Indian Search & Rescue Region (ISRR).

(i) **Maritime Incidents.** A total of 14 incidents were reported in Maritime Zones/Search and Rescue Region of India in Sep 25.

(aa) **Distress.** Two distress incidents were reported onboard Indian Fishing Boats due to sinking in Sep 25. Of the 20 fishermen onboard IFBs, 17 were rescued and 02 bodies were recovered by SAR agencies while one (01) survivor/body remained missing.

(ab) **Man Over Board.** Four cases of Man Overboard (MOB) were reported in Sep 25. Two were reported by IFBs while one each was reported by MV and Tug. 01 fisherman was rescued by local fishing boat, 02 bodies were recovered and one survivor/body still missing.

(ac) **Drowning.** Three cases of beach drowning were reported in Sep 25. All these cases were reported on Tamil Nadu coast.

(ad) **Medical Emergency.** Two cases of Medical Emergency were reported onboard MV Haje Nafela and MT Fareeda 5 respectively. ICG coordinated safe evacuation of both the patients.

(ae) **Overdue.** One incident of overdue IFB was reported in the month of Sep 25. IFB reached Tanur fishing harbour Kerala safely with the help of another Kerala based IFB.

(af) **Stranded.** One incident of stranded IFB was reported due to engine failure. The IFB reached harbour safely with assistance of another fishing boat.

(ii) **Contraband.** One incident of contraband seizure was reported in the month of Sep 25. ICG seized 96 kg of Tendu Leaves and 118 kg Dry Ginger off 3rd Island near Mandapam.

Security drill 'Sagar Kavach-2' begins

Bhubaneswar: A two-day joint coastal security exercise, Sagar Kavach-2, began on Wednesday morning along the Odisha and West Bengal coastlines, bringing together multiple defence, paramilitary, and civilian agencies to test preparedness against seaborne terrorist threats. The large-scale drill involves the Indian Navy, Indian Coast Guard, Marine police, Central Industrial Security Force (CISF), forest and fisheries departments, customs, district administrations, Paradip Port authorities, and representatives from key industrial establishments. Held twice a year, the exercise was introduced after the 26/11 Mumbai terror attacks to bolster coastal security architecture. For the mock drill, forces have been split into two groups.

4th Coast Guard Global Summit



A two-member Indian Coast Guard (ICG) delegation, led by Director General Paramesh Sivamani, AVSM, PTM, TM, Director General Indian Coast Guard, is participating in the 4th Coast Guard Global Summit (CGGS) at Rome, Italy from 11-12 Sep 25. The Summit is being attended by delegates from 115 countries and international organisations, reflecting its stature as a premier global forum for Coast Guard cooperation. The Summit serves as a forum for sharing experiences and best practices across diverse areas, including Maritime Safety and Marine Environment Protection — such as emergency response to major pollution incidents, natural disasters, and marine accidents. It also addresses Maritime Security, with a focus on countering transnational maritime crimes through advanced technologies; human resource development and training; and strengthening inter-regional and international cooperation under shared principles of conduct as "Guardians at Sea." Recognising the growing complexity of maritime challenges at the global level, the Japan Coast Guard and the Nippon Foundation convened the first CGGS in year 2017. Since then, the Summit has evolved into a key mechanism for dialogue and confidence-building among Coast Guards worldwide.
