INTRODUCTION

1. The Indian Coast Guard (ICG) was established on 01 Feb 1977, as an armed force of the Union, with the mandate of ensuring the safety, security and stewardship of India's vast maritime interests. Operating under the Ministry of Defence, the ICG has grown into a formidable force dedicated to the mission of "protecting India's maritime interests and enforcing maritime law over the vast Maritime Zones of India."
2. On the occasion of 79th Independence Day, Indian Coast Guard organised nationwide events/ activities including Tiranga March and distributed flags to school children in Coastal areas under 'Har Ghar Tiranga' campaign for promoting the national fervour and patriotism. In addition, 'Run for Unity', Walkathon and Bike Rallies were also conducted at different locations.
3. On the eve of the 79th Independence Day, the Hon'ble President of India, Smt Droupadi Murmu, conferred the Tatrakshak Medal (TM) to 05 ICG personnel. These awards recognise their gallantry, exceptional duty & meritorious service.
4. Despite the challenges posed by the South West monsoon, the ICG maintained a robust operational pace. The force remained alert and responsive, undertaking critical missions including Search and Rescue (SAR) operations, Medical Evacuations (MEDEVAC), anti-smuggling drives, marine pollution control and MZI patrols. These activities highlight the ICG's unwavering commitment to its duties and mission.

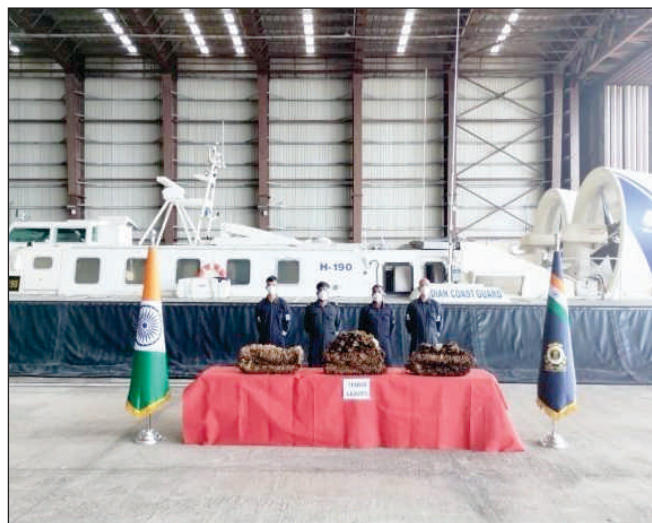

MAJOR OPERATIONS

A. Anti-Smuggling Operation.

On 07 Aug 25, based on an input, ICG carried out a swift anti-narcotics operation and seized 100 Kilograms Tendu leaves from Manali Tivu Island. The seized consignment was handed over to Revenue Department, Rameshwaram for further legal action.

B. Anti-Poaching Operation.

On 24 Aug 25, ICG conducted anti-poaching operation and seized 350 Kilograms of illegal Sea Cucumbers from Myanmar boat worth ₹ 35 Lakhs off Paget Island, Andaman & Nicobar. The seized consignments alongwith boat was handed over to local police for further legal action.

A. SAR Efforts for Capsized Indian Fishing Boat Maa Kali-194 (IND-OR-01-MO-5521).

On 02 Aug 25, ICG received information from Marine Police, Bhubaneswar regarding capsizing of IFB Maa Kali-194 with 04 fishermen off Baliapal fishing harbour, Balasore, Odisha. On receipt of information, ICG Ship and aircraft were tasked for SAR and aerial surveillance respectively. Further, 02 fishermen were rescued and the body of one fisherman was recovered.

B. SAR Efforts for Missing Fisherman from Capsized IFB Rosaria.

On 06 Aug 25, ICG received information from a local fisherman regarding capsizing of unregistered IFB Rosaria with 06 fishermen onboard in position 09 N miles South-East of Anjengo, Kerala. Out of six, five managed to swim ashore and one fisherman was reported missing. On receipt of information, ICG surface and air assets were tasked for search of the missing fisherman. The body of missing fisherman was recovered at Kannanthura beach, Vettucaud on 10 Aug 25.

C. Explosion onboard MT Fulda (IMO – 9185865).

On 06 Jul 25, an explosion occurred onboard Hong Kong flagged Chemical Tanker MT Fulda in position 19 Miles East of Mundra, Gujarat. At present, the vessel is at anchor and being managed by a four-member caretaker salvage team. Further, arrest warrant i.r.o the vessel has been revoked by Hon'ble High Court of Gujarat on 20 Aug 25 under Admiralty Suit.

D. Sinking of MV MSC ELSA 3 (IMO – 9123221).

Diving Support Vessel (DSV) MV Southern Nova arrived at wreck site on 03 Aug 25. Further, MV Southern Nova alongwith Offshore Supply Vessel (OSV) Monarch commenced saturation diving operations for fuel extraction on 20 Aug 25. A one-mile exclusion (no-fishing) Zone has been established around the wreck site for safe diving operations with continuous monitoring by Tug Canara Megh. The diving team extracted 13 tons of fuel by end Aug 25, as the operation continues.

E. Fire onboard MV Wan Hai 503 (IMO – 9294862).

On 09 June 25, a container explosion triggered a major fire aboard the Singapore-flagged vessel MV Wan Hai 503, approximately 130 nautical miles northwest of Kochi. Post fire fighting operation that continued for several weeks, the situation was brought under control. The vessel was monitored throughout for environment safety concerns. The vessel started heading towards Jebel Ali, UAE on 23 Aug 25 and was in position 258 N miles from Aguada Lt on 31 Aug 25.

B. Exchange of Terms of Reference between Indian Coast Guard (ICG) and Philippine Coast Guard (PCG).

On 05 Aug 25, Indian Coast Guard and Philippine Coast Guard exchanged Terms of Reference (ToR) at Hyderabad House, New Delhi marking a key milestone under the MoU signed between ICG and PCG. The exchange took place during India – Philippines Bilateral Meeting. This enhances cooperation in Maritime Search & Rescue, Maritime Patrol & Response and Maritime Law Enforcement between the two agencies.

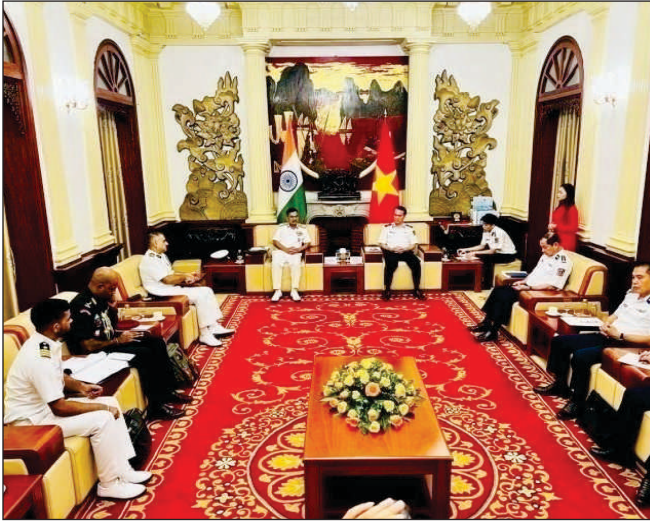

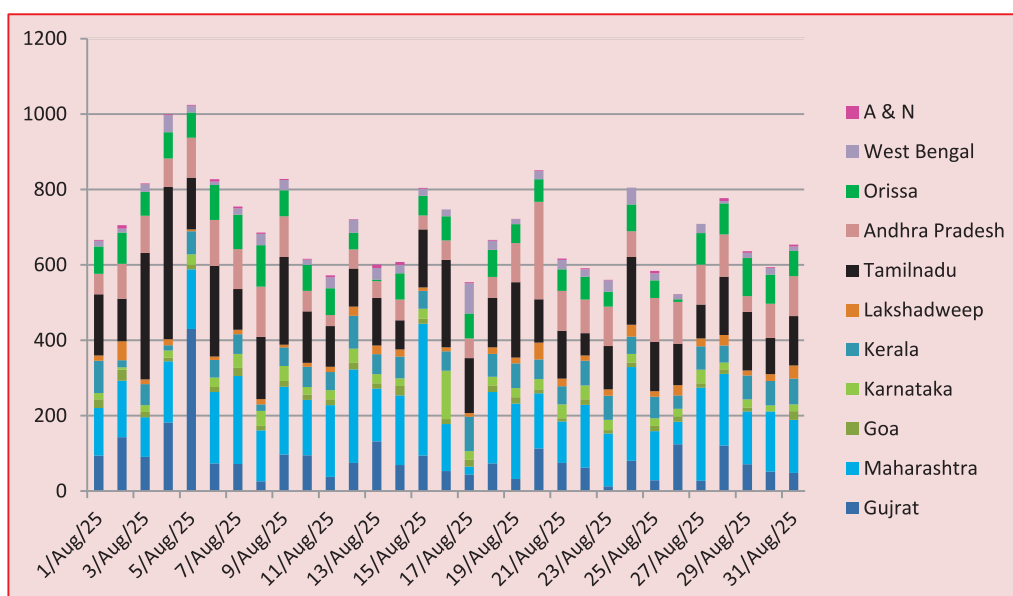

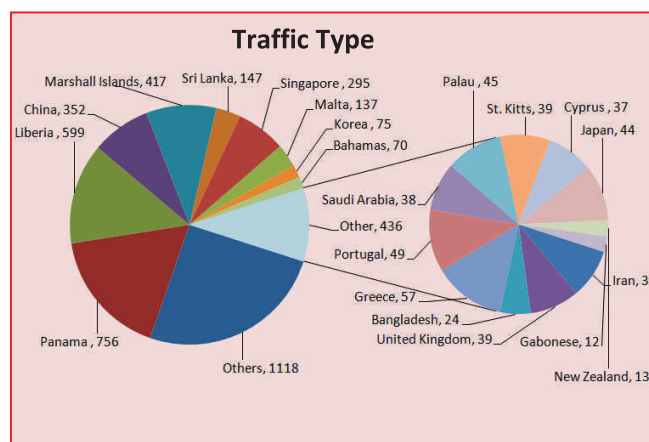
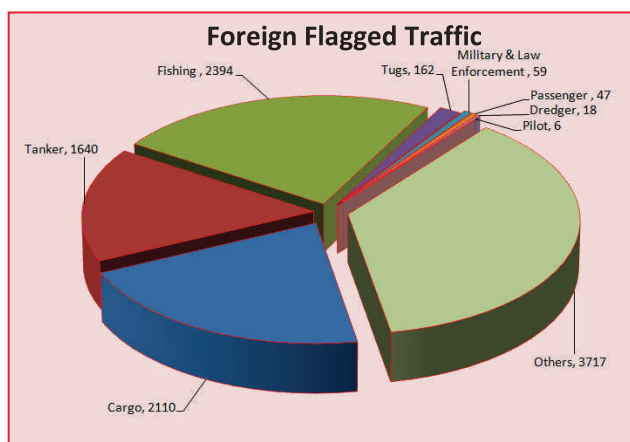
The trend analysis (maritime traffic, fishing activity and maritime incidents) for Aug 25 is enumerated in succeeding paragraphs.

C. Coastal Maritime Traffic.

Indian Coast Guard monitored 10,153 distinct AIS transmissions on CSN network along Indian coast in the month of Aug 25. Traffic share of India, Panama, Liberia, Marshall Islands, China & Hong Kong and



Singapore stood at 57%, 07%, 06%, 04%, 03% and 02% respectively. The larger share of India flagged traffic is attributed to coastal traffic. Traffic share of Cargo and Tanker vessels are 21% and 16% respectively. A total of 3,283 vessels were investigated by ICG ROSSs. The state-wise, flag-wise and type-wise traffic pattern is as depicted .



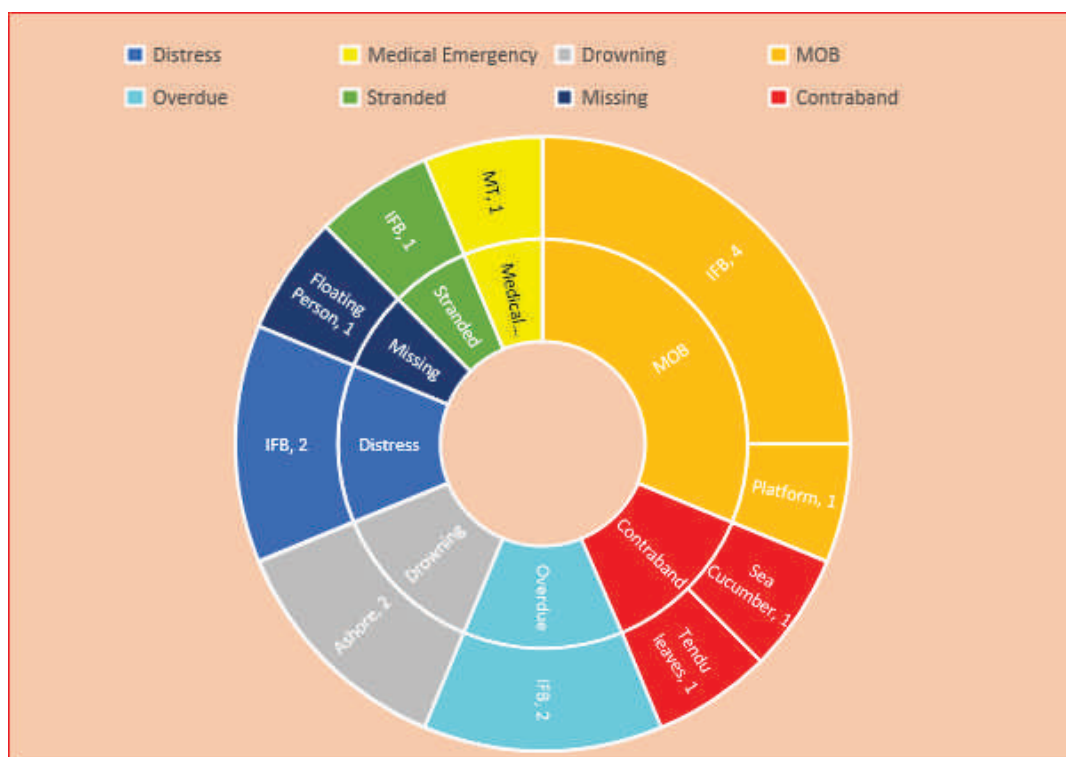
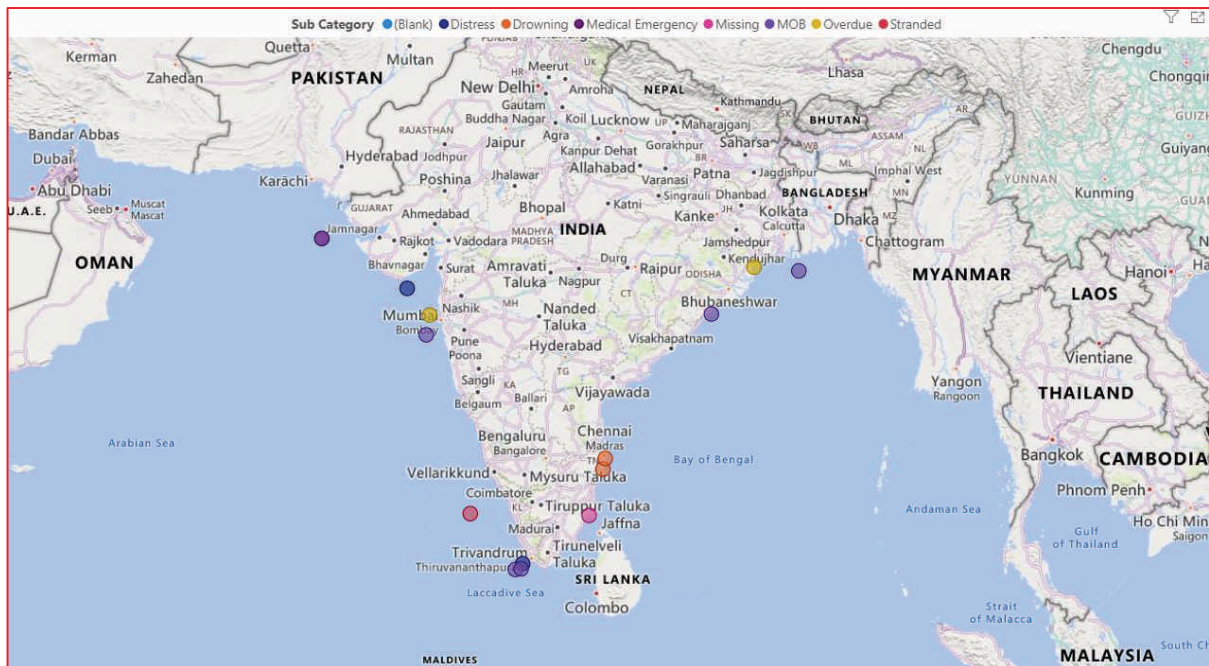
D. Fishing Activity in North Indian Ocean.

A total of 2,416 Fishing Vessels (FVs) were observed transmitting on AIS in Northern Indian Ocean in the month of Aug 25. The analysis of fishing activities is based upon kinematics such as low speed. The data towards numbers of FVs have been garnered from AIS transmission. However, the actual numbers of FVs may be higher than the reported data as many FVs may not be transmitting on AIS. The area wise analysis of FVs operating in Bay of Bengal & Arabian Sea (beyond EEZ) and Indian EEZ for the month of Aug 25 is as follows: -

- (i) **Arabian Sea (Beyond EEZ).** A total of 21 FVs were observed transmitting on AIS and appreciated to be engaged in fishing. Out of these, numbers of Sri Lankan and Indian FVs are 19 and 02 respectively. No FVs of China and Pakistan was observed transmitting on AIS during the period. Majority of FVs withdrew from area by end of May 25 which may be due to onset of monsoon or voluntary fishing moratorium declared by flag state. No Chinese flagged fish carrier (Reefers) were observed operating in Arabian Sea.
- (ii) **Indian EEZ.** A total of 2,394 Indian flagged FVs were observed transmitting on AIS.
- (iii) **Bay of Bengal (Beyond EEZ).** A total of 01 Sri Lankan FV was observed transmitting on AIS and appreciated to be engaged in fishing. No other FVs were observed transmitting on AIS in high seas in Bay of Bengal.

COASTAL SECURITY/ SURVEILLANCE

E. Maritime Incidents & SAR Cases in Maritime Zones of India (MZI) and Indian Search & Rescue Region (ISRR).

(i) **Maritime Incidents.** A total of 14 incidents were reported in Maritime Zones/Search and Rescue Region of India in Aug 25.

(aa) **Distress.** Two distress incidents were reported in Aug 25. Both incidents of distress occurred due to capsizing of Indian fishing vessels which were due to inclement weather. Of the 33 crew onboard IFBs, 21 were rescued and 01 body recovered by SAR agencies. However, 11 crew were missing.

(ab) **Stranded.** One incident of stranded Indian Fishing Vessel was reported in Aug 25. IFB reached harbour safely with assistance of other fishing boat.

(ac) **Man Over Board.** Five cases of Man Overboard (MOB) were reported in Aug 25. Four were reported by IFBs while one was reported by ONGC Platform. One body was recovered by IFB and four survivor/bodies remained missing.

(ad) **Drowning.** Two cases of beach drowning were reported in Aug 25.

(ae) **Medical Emergency.** One Medical Emergency was reported onboard MV Faithful Warrior. Tug arranged by local agent, evacuated the patient & shifted to unique hospital, Jamnagar.

(af) **Overdue.** In Aug 25, two incidents of overdue Indian Fishing Boats (IFBs) were reported. In the first case, the IFB safely reached Arnala Harbour. In the second case, however, the boat could not be located; of the four fishermen onboard, two were rescued, one body was recovered and one fisherman remains missing.

(ag) **Missing.** One incident of missing person was reported off Nagapattinam in the month of Aug 25. The person was floating and recovered by ICGS Rani Durgavati and handed over to local CSG station for further investigation.

(ii) **Contraband.** Two incidents of contraband seizure was reported in the month of Aug 25. ICG seized 100 kgs of Tendu Leaves off Manali Tivu Island and 350 kgs sea cucumber worth of approx. Rs 35 lakh off Paget Island (A&N).

to work closely in addressing contemporary maritime challenges, ensuring safety, security, and environmental stewardship in the shared maritime domain.

The meeting underscored the mutual resolve of ICG and SLCG to deepen operational coordination, share best practices, and further promote

regional maritime stability through sustained cooperation, the release stated. The SLCG delegation is visiting India from 10-14 August 2025, for the HLM and other professional interactions under the framework of the Memorandum of Understanding signed between the ICG and SLCG in 2018.

Plate Cutting Ceremony: ICG Next Generation Offshore Patrol Vessel Held At MDL



The Plate Cutting Ceremony of Yard 16404, the fourth in the series of six Next Generation Offshore Patrol Vessels (NGOPVs), was held today at M/s Mazagon Dock Shipbuilders Ltd (MDL), Mumbai. The ceremony was presided over by Inspector General NG Raveendran, TM, Deputy Director General (Technical), Headquarters Coast Guard Eastern Seaboard (HQ CGES), in the presence of Mr. A. Vinod, Executive Director (Shipbuilding), MDL, along with senior officials from the Indian Coast Guard (ICG) and MDL. The contract for the construction of six NGOPVs was concluded on 20 Dec 23. The vessels are being indigenously designed, developed, and constructed by MDL under the 'Buy (Indian-IDDMM)' category, aligning with the Government of India's vision of Aatma Nirbhar Bharat (Self-Reliant India).

Measuring 117 meters in length, with a complement of 11 officers and 110 men, each vessel will be capable of achieving speeds up to 23 knots and will have an operational range of 5,000 nautical miles. These NGOPVs will be equipped with state-of-the-art machinery and cutting-edge technologies, AI-based predictive maintenance systems, Remote piloted drones, Integrated Bridge System (IBS) and Integrated Platform Management System (IPMS).
