RECRUITMENT OF ENROLLED FOLLOWER (SWEEPER/ SAFAIWALA)

- 1. Regional Headquarters (A&N), Sri Vijaya Puram had invited applications for 01 (UR) post of Enrolled Followers (Sweeper/ Safaiwala) vide advertisement published in two local dailies "Daily Telegrams" (English Edition) and "Dweep Samachar" (Hindi Edition) through Govt Press, Sri Vijaya Puram and CG personnel recruitment website.
- 2. The maximum/total marks for the written examination for each post were 50. The Passing marks is 50% for General category.
- 3. The list of all the candidates appeared in written examination alongwith their marks obtained is placed at **Appendix 'A'**.
- 4. The Written Examination, Professional Skill Test and Physical Fitness Test for recruitment of one unreserved vacancy of Enrolled Follower (Sweeper/ Safaiwala) was conducted on 24 Jun 25. Post completion of Written Examination, Professional Skill Test and Physical Fitness Test, Primary Medical Examination of 03 candidates was undertaken at MI Room, CGDHQ-14 (PBR), Sri Vijaya Puram on the same day ie 24 Jun 25 and were found medically Ty Unfit. Upon re-Medical Test at INHS Dhanvanatari, Sri Vijya Puram all three candidates passed the medical test and were declared medically 'Fit'. List of candidates qualified in written examination and appeared for Professional Skill Test (PST), Physical Fitness Test (PFT) and Medical Examination is placed at **Appendix 'B**'
- 5. Final list of candidates who qualified Written Examination, Professional Skill Test (PST), Physical Fitness Test (PFT) and Medical Test is placed at **Appendix 'C'.**
- 6. The appointment of standby candidate will be subject to non-reporting/ non-joining of candidate to the said post in accordance with the vacancies and merit list as published within the stipulated time period of filling up of said vacancy.
- 7. Provisional appointment will be issued to the selected candidate on receipt of the documents specific in the Appointment Letter. Appointment in ICG is Provisional and subject to satisfactory verification of credentials/documents of the candidate.
